The scaling is based on a Lickert 5-point scale with quality measures from poor (0) to excellent (5).



Analysis of Feedback :

The importance of faculty feedback on course material is widely recognized a scritical to improving educational quality. Cottogenian sees a foundation for making improvements to the present system. A total of 5 faculties took part in the survey. The suitable ideas are given to the academic dean for execution based on the comments collected.



Analysis:

- 1. The entire faculty says that sequence of courses provided in the program is appropriate.
- Faculties were asked to comment on syllabus regarding the depth of the syllabus for the course in relation to the competencies expected by industry/current global scenario majority of them commented good and very good respectively on both the parameters.
- In case of adequateness of textbook and reference book mentioned of the course the 60.00% faculties commented excellent & very good and 20.00 % faculties commented satisfactory for both of the parameter respectively.
- 4. For the parameters such as the potential of the students in understanding the course objectives the 60.00% faculties commented excellent & very good and 20.00% faculties commented satisfactory respectively.
- Majority of faculties say good to syllabus regarding the syllabus has a good balance between theory and application.

During feedback suggestions received from students are as follows:

- Organize training sessions on new teaching methods and upcoming subject areas.
- 2. To improve skill set of staff to optimize ICT enabled teaching.
- To provide opportunity to update knowledge in publication ethics, preparation and uploading of manuscripts for publication in peer reviewed journals.
